

GENERAL CONDITIONS OF SERVICE

MUSEO NACIONAL THYSSEN BORNEMISZA

The website <https://entradas.museothyssen.org> (the "Ticket sales website") is the property of FUNDACIÓN COLECCIÓN THYSSEN-BORNEMISZA, F.S.P., the "FOUNDATION"), tax identification number G-79015251, with address at Paseo del Prado 8, 28014 Madrid, a Foundation registered on 3 March 1989 in the Registry of Private Cultural Foundations of the Ministry of Education, Culture and Sports with number 225, at page 24.

The ticket sales service is provided by the FOUNDATION through a platform managed by TIQUETE SPAIN, S.L., with registered office in Barcelona, at C/Álava, 140-146-5º 3ª 08018-Barcelona and tax identification number B66045345, registered in the Commercial Registry of Barcelona, at Sheet B-437914, Volume 43775, Page 2.

The access to and use of this Ticket sales website implies the knowledge and acceptance of the general terms and conditions of use of the museothyssen.org websites, as well as of the following terms and conditions.

SPECIFIC TERMS AND CONDITIONS OF THE TICKET SALES WEBSITE

Through the Ticket sales website, users can purchase tickets, in advance, to exhibitions and other events held by the FOUNDATION. The advance ticket sales service is generally provided 24 hours a day, 365 days a year. However, the FOUNDATION may at any time temporarily or permanently suspend, without the need for prior notice, the advance sales service of all or part of the tickets to the permanent exhibition, temporary exhibitions or other events organised by the FOUNDATION.

TERMS FOR PURCHASING TICKETS

Users of this website may purchase their tickets in advance based on the instructions indicated at the top of the page.

The purchase of tickets is not subject to the right to cancel. No changes or refunds are allowed. However, the total or partial refund of the amount paid for the tickets will be made by the FOUNDATION in the event that the exhibition is suspended or substantially modified, except in those cases in which the suspension or modification occurs once the user has accessed the exhibition and the suspension or substantial modification was due to force majeure. All of the above is without prejudice to any claims that may be applicable in accordance with the applicable civil and commercial regulations.

USE OF TICKETS PURCHASED THROUGH THE WEBSITE

The tickets that are purchased in accordance with the provisions of the previous section, and that the users receive in their email, will have the same value as if they had been purchased in the Thyssen-Bornemisza National Museum.

The users of the Website may:

1. Print their tickets on plain paper, whilst checking that the print is correct and that the codes that identify and individualise each ticket are legible.
2. Download on their mobile handset the file in .pdf format that the user receives by email and show it at the entrance of the Museum.
3. Download the tickets they receive in their email in passbook format.

The tickets will entitle the holder to access the exhibition or the event for which they were purchased and they will be valid for a single use.

The FOUNDATION reserves the right to require the Museum visitors who have purchased their tickets at a free, reduced or discounted rate through the Ticket sales website, to show their national identity document or passport, as well as the documentation that determines the application of a free or reduced or discounted rate -except in those cases in which the tickets were purchased through a tour operator or another intermediary- in order to verify the correct application of the rates, to control access to the Museum and the lawful use of the advance ticket sales service through the website.

The FOUNDATION may also require users who have purchased a special ticket at a reduced price due to age or any other circumstance existing at the time of purchase, to prove such circumstances.

LIMITATIONS OF USE

Users who access this Website are authorised to view all of its information and contents, as well as to carry out private downloads or reproductions of it on their handsets or on any data storage medium, as long as the reproduced elements are intended EXCLUSIVELY FOR PERSONAL USE OF THE USER and are not subsequently transferred or transmitted to third parties.

It is expressly prohibited to install the information and contents on any handset or server directly or indirectly connected to the Internet or a local network and that allows third parties to access it through means other than the Website itself.

The use of the Website for the purchase of tickets by the user that are to be subsequently subject to resale for the same or another price is also prohibited.

INCIDENTS WITH THE TICKET SALES SERVICE

TERMS OF ACCESS

- b. Temporarily interrupt the service, without prior notice and at any time, for technological or legal reasons.
- c. Amend the terms for providing the service.
- d. Block access to or use of the service by a user who has used it incorrectly or in relation to whom fraudulent use of the service or means of payment is suspected.

Furthermore, the FOUNDATION will file the electronic document in which the purchases are formalised, which will not be accessible to the visitor.

LIABILITY

The FOUNDATION will not be held responsible for the damages or losses of any nature that may result beyond the FOUNDATION's control. Among others, the FOUNDATION assumes no responsibility for any interruption, error or fault that may occur in the Website or the payment systems agreed with the bank entities, transmission of virus or malware caused by a third party, nor for informations, opinions or content of any kind that are included in other websites that are not managed by the Foundation, to which this Website may redirect users through hypertext links.

Furthermore, the FOUNDATION will also not be responsible for any interruption, error or fault that may occur in the system as a consequence of a malfunction of the network or the servers connected to it.

The FOUNDATION will not be liable for any harm or loss of any nature that may occur due to lack of availability or continuity in the operation of the service.

Furthermore, we hereby inform you that TIQUETEO SPAIN, S.L., who manages the ticket sales platform of the Foundation, is the processor of this data.
